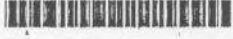

Hence the following amendments/ additions/ deletions shall come into effect from this date:


1. The clauses 5 to 15 of the **DEED OF TRUST** are replaced with the following:
 6. The number of Trustees shall not be less than 4 (four) and not more than 7 (seven) excluding ex-officio Trustees. The Board of Trustees may by a resolution passed validly in the meeting of the Board of the Trust, co-opt as ex-officio Trustees, the President or the General Secretary of the society, Bharatiya Samskriti Vidyapith (Regd.) 76 (old 29), First Main Road, Chamarajpet, Bangalore – 560018 (PAN AAKPP5834H) as Trustees who shall be ex-officio trustees of the Trust.
 7. There shall be two types of trustees: 1. Life Trustee and 2. Regular Trustee. Smt. K.N. Puttamma, Sri. P. Achutha Rao, Sri. K.N. Venkatesh and Smt. Usha Acharya shall be Life Trustees during their life time. Other trustees shall be Regular Trustees who shall hold office as specified in clause 9 below. The period of term of office fixed for the Regular Trustees will not apply to Life Trustees.
 8. After the lifetime of Smt. K.N. Puttamma, the number of Life Trustees shall be not more than 3.

9. The Life Trustees excluding Smt. K.N. Puttamma can nominate one person as his/her successor and the nomination shall be approved by resolution by a simple majority. A Life Trustee can change the nominee any number of times with the approval by Board of Trustees by resolution by a simple majority. In case a casual vacancy arises by death, resignation or the Life Trustee becoming insolvent, the most recently nominated person by such Life Trustees shall replace the said Life Trustee as the Life Trustee.

10. The term of office of the Regular Trustees shall be three years or such lesser period as may be decided by the Board and on completion of term, they shall retire and will be eligible for reappointment.

11. The ex-officio trustees co-opted will retire by their ceasing to be in office by virtue of which they had been co-opted as ex-officio trustees.

12. a) Mrs. K.N. Puttamma, a founder Trustee shall be the Managing Trustee during her life time.

b) Subsequent Managing Trustee shall be elected / selected by the Life Trustees who shall hold the office of the Managing Trustee for a period of Two years.

13. Powers and Duties of the Managing Trustee:

- a. The Managing Trustee shall preside over all meetings of the Trust and be the Chief Controlling Authority of all the affairs of the Trust.
- b. The Managing Trustee shall be bound by the decisions of the majority of Trustees present and voting and in the event of equal division, the Managing Trustee shall have the casting vote.
- c. The Managing Trustee shall scrutinise the record of the proceedings of the meetings of the Board of Trustees as to its correctness in the light of the discussions transpired in the meeting and sign the same.
- d. The Managing Trustee shall take all steps and actions necessary to further and to achieve the objectives of the Trust and shall guide and instruct other Trustees in all matters and affairs of the Trust.
- e. The Managing Trustee shall order and certify payments in accordance with the resolutions of the Board of Trustees independently or otherwise.

14. Operation of Bank Accounts:

The Bank accounts of the Trust shall operated by the Managing Trustee along with any other Life Trustee. The Managing Trustee shall not operate the bank account for a period of two years immediately after vacating the seat of Managing Trustee. However he/she can continue to operate the bank account with the permission of all other Life Trustees.

15. CESSATION OF TRUSTEESHIP:

a. A Trustee shall cease to be Trustee under the following circumstances:

- i. If a Trustee is charged with allegations of misconduct or misappropriation in any other organisations;
- ii. If a Trustee is convicted by a competent court of law for any offence involving moral turpitude;
- iii. If a Trustee were to act against the interest of the Trust in any manner or to cause monetary loss to the Trust and on such grounds and on the Board of Trustees to disqualify a Trustee by 2/3rd majority of the Board;
- iv. A Trustee were to become lunatic or insane;




